The Daily Diary is a log sheet of appointments and phone calls maintained by the White House secretaries.

The Diary Backup contains preparation material, press releases, and schedules for meetings and appointments, as well as some reports and notes from the meetings.

NATIONAL SECURITY FILE

This file was the working file of President Johnson's special assistants for national security affairs, McGeorge Bundy and Walt W. Rostow. Documents in the file originated in the offices of Bundy and Rostow and their staffs, in the various executive departments and agencies, especially those having to do with foreign affairs and national defense, and in diplomatic and military posts around the world. More than one-half of the National Security File has been processed. Consult the finding aid in the Reading Room or borrow a lending copy by writing to the Supervisory Archivist, LBJ Library, 2313 Red River Street, Austin, Texas 78705. Those folders whose titles are preceded by an "X" or a date have been processed and their contents declassified in whole or in part. Lists of classified documents have been placed in those folders, and you may request mandatory review of individual documents which have not yet been declassified in full. Those folders not preceded by an "X" or a date are unprocessed and are not subject to mandatory declassification review. Consult with a member of the staff on the processing schedule.
